



Dear Parent(s)/Guardian(s),

Social, emotional learning (SEL) services at Mountain Sunrise Academy are offered during school hours. They may include individual or group skill training in topics such as healthy tools for regulating emotions, making and keeping friends, setting goals, building confidence, mindfulness, team work, conflict resolution and responsible decision making. Safety screening is also provided on an as needed basis to connect those at high-risk with community resources and specialized support. All services at Mountain Sunrise Academy are short-term and limited in frequency. The purpose of these sessions is to help with problems in life that may be keeping a student from being successful at school. They do not take the place of or provide diagnosis or professional treatment for mental or medical health needs. If you feel your student needs more frequent sessions or has barriers that significantly impact their life beyond school, you may want to seek assistance outside of the school environment. All related costs for services outside of school are the responsibility of the parent or legal guardian.

During the course of any sessions or discussions, students may discuss their personal views and experiences. Information disclosed in sessions is confidential unless not disclosing such information would be harmful to the student or others. Information concerning life-threatening situations, or harm to others will be shared with the parent and appropriate school personnel. State law requires that information suggestive of child abuse must be reported to the appropriate governmental agency. Information gathered from an interview or support session may be shared by the administrator or other school personnel only on a need-to-know basis.

Parent relationships are highly valued and parents are contacted when there is a concern with student needs. School permission slips will be kept for only one school year. If additional services are needed beyond the current school year please contact the personnel on the bottom of this form at the beginning of each school year.

Confidentiality Information for Small Groups
Parents and guardians are encouraged to contact the school service provider if they have concerns or questions about their child's growth and progress in group settings. However, the provider may not disclose the information shared between group members in order to uphold confidentiality and create a trusting environment. The information shared by the group members is confidential except for instances mentioned above.

Under Utah Code, Section 53E-9-203 of the Utah Family Education Rights and Privacy Act, schools are required to have your consent as a parent or legal guardian, except in the response to a situation which a school employee reasonably believes to be an emergency or by order of the court if psychological information is discussed with your student.

Please understand that your student cannot participate in these services unless the signed letter of permission is returned. If you consent to your student's participation, please complete this form on both sides and return it to the school as soon as possible.
