In math, the state goal is at 60% and we need to hit approx. 4-6% or more in some cases to hit that goal. However, math testing is done differently. What they test on at the beginning of the year is what they end up learning throughout the year and should know by the end of that grade. Therefore, the scores will be lower as they haven't learned that just yet.
- d. It was noted that some children have testing anxiety and some testing strategies would be nice to touch on such as familiarity, environment, having breaks, snacks and ensuring that we communicate that sleep is important and self-care needs that will help students succeed and be confident. This year is devoted to teacher professional development in best practices for teaching writing skills.
