PART 2: REQUIREMENTS, PROCESS & WHAT TO EXPECT

Step 1: Eligibility Verification

Before you can access the full application, you must submit the Letter of Intent and Pre-Application Eligibility Verification through SurveyMonkey Apply.

You'll confirm:

- Your approved application by your authorizer
- Your nonprofit status
- Whether you meet federal definitions
- Whether you're a high-quality school, expanding or replicating
- That you have notified your authorizer of your intent to apply

If approved, you'll receive access to the full application.

Step 2: Mandatory Technical Assistance

A majority of your board must attend each required webinar:

- CSP Introduction
- RFA Orientation
- Budget Support

Attendance is required, this ensures every applicant fully understands federal expectations.

Step 3: Application Submission

Opens: January 22, 2026

Closes: March 4, 2026 at 5pm*

*Applications are submitted exclusively through the SurveyMonkey Apply portal. Late or incomplete submissions cannot be accepted.

Step 4: Application Format & Required Components

The application includes:

- A detailed project narrative
- A budget and budget narrative
- A project timeline
- Evidence of authorizer approval
- Required board and governance documents
- Enrollment and lottery policies
- Financial statements for replicating and expanding schools
- Student demographic comparisons with local school districts
- Recruitment and community engagement plans, including longterm viability
- Transportation
- Academic plans

The project narrative itself covers:

- Educational model
- Transportation Plan
- Student recruitment and lottery procedures
- Governance, autonomy and project administration
- Financial management
- And optional competitive preference priorities

What happens after you submit?

Your application undergoes a rigorous, multi-step review:

- 1. Peer Review Committee Scoring
 - Experts in charter governance, finance, authorization, special education, and operations score each section.
- 2. Capacity Interview
 - A live Zoom interview to assess your readiness, your team's capacity, and your ability to manage federal funds.
- 3. Final Determination
 - Scores, interview results, and alignment with program goals determine whether a school is funded.

Post-award: What CSP Expects

If your school receives a subgrant, you'll participate in:

- Quarterly fiscal and programmatic reviews
- Site visits
- Ongoing technical assistance
- Monitoring of enrollment, fiscal controls, equity practices, and academic performance

Your risk assessment determines how much support you'll receive—from one-on-one mentoring, to staff monitoring, to group technical assistance.

How do you know if you're ready to apply?

Ask yourself these questions:

- 1. Is there clear demand in your community?
- 2. Is your governance board stable, trained, and actively engaged?
- 3. Does your school have a strong, research-based educational model?
- 4. Can your team manage a federal grant with strict compliance requirements?
- 5. Have you built strong relationships with your authorizer and community partners?
- 6.Do you have the people and systems to meet reporting, financial, and academic expectations?

If your answer to most of these is "yes," applying could be the right next step.
